DEAN'S ADDRESS

Law, whether as a discipline or a profession, is at a crossroads. While some see only uncertainty, we here at SMU School of Law see opportunities. From the legal implications of emerging technologies such as artificial intelligence, blockchain and smart contracts, to Singapore's legal and economic opportunities in ASEAN and with the two emerging Asian giants, you can find our faculty providing thought leadership. Our faculty are culled from distinguished international universities, and their world-class research frequently find their way to you in the classroom.

We are prime movers in the legal education landscape. Pioneering small class teaching and superior learning experience, we continue to bridge the distance between instructor and student. Through clinical work and industry collaboration, we have gone beyond the traditional teaching of theory to incorporating practical experience in the classroom. What helps is the proximity of our new state-of-art building to the courts, Parliament, and the legal and financial heart of Singapore. This fosters an almost natural synthesis between law in the books and law in practice. We emphasise presentation skills so that our students graduate both articulate and confident. Presciently, ours is the first law school in Singapore to require graduates to engage in community outreach; this was such a success that pro bono hours thereafter became mandatory for law schools nation-wide. We continue to view law as a noble calling, and therefore it is our responsibility to inculcate in our students the value of giving back to society. In

short, our LLB programme is carefully designed and curated to nurture intellectual curiosity and creativity, meeting the demands of the ever-changing market, while at the same time helping our graduates find their proper place as leaders in society.

This is why our graduates are highly sought after, well placed, and competitively remunerated. Our graduates are significantly represented on the prestigious Justices' Law Clerks programme and have gone on to make their mark in the profession, industry and academia. What is more, within a short span of ten years and with only six cohorts of working graduates, quite a few of our graduates have already struck out on their own to set up their own private practice and legal-tech start-ups. With an alumni network numbering more than a thousand and growing steadily, current students truly benefit from networking and job opportunities.

All our faculty have postgraduate degrees from world-renowned universities, such as the University of Oxford, the University of Cambridge, Harvard University and Yale University; about one third have PhD qualifications.

In both research and teaching, we draw on our diverse backgrounds and experience. Some of our faculty members are practising lawyers and legal consultants. Others are appointed to leadership roles in institutions such as the Singapore Institute of Legal Education and the Singapore Judicial College. Cutting-Edge Research

Our faculty members conduct research into a broad variety of subjects, from traditional disciplines such as the law of property and company law, to rapidly developing areas such as information technology and data protection law (Warren Chik, Saw Cheng Lim, Kelvin Low and Eliza Mik). We frequently publish in leading law journals such as the Oxford Journal of Legal Studies, the Cambridge Law Journal, the Law Quarterly Review, the Modern Law Review and Legal Studies.

We are also known for exchanging ideas with leading scholars worldwide at prestigious conferences and conducting seminars that share cutting-edge legal knowledge with the legal community. As a student, you will be exposed to this process through research papers, the Directed Research elective, and opportunities to be engaged as Research Assistants.

Engagement with the Community

Our faculty members also lead the School of Law's specialist research centres, the Centre for Cross-Border Commercial Law in Asia (CEBCLA), helmed by Professor Tang Hang Wu and Associate Professor Yip Man, and the Applied Research Centre for Intellectual Assets and the Law in Asia (ARCIALA), helmed by Professors Liu Kung-Chung and Irene Calboli. These are centres of excellence which forge strong links with international business and academic communities through rigorous, relevant, and innovative research with practical applications across Asia.

We are also home to the Singapore International Dispute Resolution Academy (SIDRA), helmed by Professor Nadja Alexander. SIDRA engages in leading research on negotiation and dispute resolution, and provides practical training to professionals, from local counsel to international arbitrators. Our students benefit from opportunities to attend events such as seminars by leading speakers, and to assist in innovative research.

In addition, we serve the broader Singapore community through the Pro Bono Centre (PBC), helmed by Associate Professor Rathna Koman. PBC promotes the ideal of equal access to justice for all parts of society. It is spearheaded by faculty members who have both expertise in criminal law and rich practical experience, and who have cultivated links to agencies such as the Law Society of Singapore and the Community Justice Centre at the State Courts. As a result, our faculty members equip students with practical professional skills while empowering them to exercise a strong sense of social responsibility.



FORWARD-LOOKING EDUCATION

Unique Teaching Style

As a student, you will be taught in an interactive style, where a single instructor leads a class of around 40 students through 12 weeks of rigorous seminars. This departure from the traditional lecture-and-tutorial mode of learning will allow you to acquire knowledge and problem-solve at the same time. You are expected to prepare for each seminar by completing pre-assigned readings so that you can participate in vibrant class discussions. Group presentations, written assignments, and active class participation are means additional to exams in which you are evaluated.

For skills-based courses, the focus is on hands-on work and closely supervised assignments. Legal practitioners and alumni are regularly invited to give talks to students, providing practical perspectives on how theory is applied. In SMU-X courses, experiential learning is taken to the next level as students engage in projects that require interdisciplinary knowledge and active mentoring. Our holistic pedagogy ensures our students graduate as dynamic, articulate, and analytically agile individuals ready to thrive in legal practice.

Rigorous Internship Programme

Through our internship programme, we train you to be practice-ready graduates who can thrive in a range of environments. Internships are critical in exposing students to the practical workings of the legal system. Our students are required to complete at least 10 weeks of internships before graduation. They may choose to intern with the wide variety of law firms, legal departments, and government bodies we have partnered with. Our vast network even makes it possible for students to intern overseas.

Conscientious Community Service and Pro Bono Work

As a student, you will learn the importance of law as a noble calling through giving back to society. Our students are required to complete at least 80 hours of community service before graduation, of which 20 hours constitute pro bono work. Besides contributing to access to justice through the campus legal clinics run by our Pro Bono Centre, our students undertake pro bono projects in conjunction with institutions such as the Law Society and the Community Justice Centre. Through assisting practicing lawyers providing these services, our students are sensitised to the wider legal needs of our community.

Law as Calling

Ultimately, we believe that law is not only a practice, but also a calling. Under a programme put together and personally sponsored by our faculty, students attend lunch time talks given by having experience in work that complement the institution or practice of law. The objectives are to give our students an opportunity to be inspired by people who have persevered in doing good, to facilitate their understanding of the role that law and the profession play alongside other structures in society, and to help them see the “human” side of law.

We partner with universities worldwide in direct law-to-law and university-wide exchange programmes and are continually expanding our international exchange programme offering. We are the only Asian university in the THEMIS network of renowned European universities.

While we are familiar with class presentations as a normal part of SMU’s curriculum, the Masters Programme in Ghent University, from which we were allowed to pick courses, challenged the norms of continual assessment: from having the class conduct a student-led public conference, to the emulation of a court hearing before the Court of Justice of the European Union (“CJEU”). We also had the opportunity to deepen our understanding of European Union law through an organised visit to the CJEU in Luxembourg, and from our interactions with the diverse composition of European students in our classes.”

Internships

Students may intern overseas with reputable law firms and related organisations of their own choosing. Our partnership with the New York State Bar Association further provides our students with the opportunity to intern with firms in New York.

Law Study Mission

Our Law Study Mission course allows students to gain a better understanding of the legal system, business and culture of selected countries. Students will visit these countries and engage in participant activities at law firms, legal institutions, governmental agencies and businesses.

International Moot Competitions



As a student, you will also have the opportunity to participate in our leading programme on international moots. Mooting is essentially a simulation of the resolution of a dispute before a court or tribunal. Although our International Moots Programme was only launched in 2010, our students have regularly placed in the top 3 worldwide in the most prestigious international moot competitions (known as “grand slam moots”) that attract participations from hundreds of universities, including:

VIBRANT STUDENT LIFE

Our strategic location near the courts, Parliament and the central business district gives our students the opportunities to experience first-hand how laws are created, how legal disputes are adjudicated, and how laws affect businesses. Our location also means that judges, top lawyers and legal service officers frequently give talks to our students or even teach full courses.

More than work, our location between Fort Canning Park, Orchard Road and the Central Business District means our students have ready access to plenty of good food, fun and opportunities for experiential learning.

New students begin this exciting journey by participating in Law Camp, an orientation camp for first year law students before the academic term. To help ease students in their transition to law school, all first-year students are assigned to members of the faculty, whom they may reach out to for academic advice. There is also a buddy system where first year students are paired with second year students. To continually engage with the students, the Dean conducts a townhall session with them every term.

Recognising that our students are important stakeholders, we strongly believe in the importance of engaging them and listening to what they have to say. Even after our students graduate, we continue to regard them as part of our family and do our best to stay connected.

We celebrated the mass call to the bar of our first cohort of LL.B. graduates, the Class of 2011, in 2012 with a mass call party, an event which has since become a yearly tradition.

Apart from fun gatherings for all alumni such as a recent barbecue on the rooftop of our new building, we actively seek the feedback and involvement of our alumni for the school's future, such as by holding a town hall in August 2017 which saw an attendance of over 60 alumni on a Thursday night!

Although we are only 10 years old, we have an extensive and supportive alumni network that spans across various industries, from the conventional private law firms to government legal service to legal tech start-ups which have been featured in the local press.

Our alumni have also gone on to pursue graduate studies in renowned institutions such as Harvard Law School, University of Oxford, University of Cambridge and Columbia University.

Many of our alumni, despite hectic schedules in the early years of their careers, readily return to volunteer in school events, such as our open house, panels to share with our students, and admissions interviews.

More than 200 alumni regularly help out with our International Moots Programme through judging, coaching, and vetting written work. This way, knowledge is passed down the generations, giving our students an edge in competitions. The success of our moot programme has been testament to the unstinting commitment of alumni who went through the programme first as students.

Our graduates are highly sought after, having close to full employment soon after graduation, with higher average starting salaries than their peers from other universities. Based on the Graduate Employment Survey published annually by the Ministry of Education, the overall employment rate for our graduates has been consistently above 95% and our graduates draw the highest average gross monthly salary. This is a testament to the quality of our graduates and shows that our education approach fits market demands.
